

Meiomi Golf Experience Sweepstakes 2024
Official Rules

NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. Eligibility: The Meiomi Golf Experience Sweepstakes (the “Sweepstakes”) is open only to legal U.S. residents residing in the state of Massachusetts (“Eligibility Area”) who are at least twenty-one (21) years old at the time of entry.
